Incoming P1 Student Requirements

Before the Fall Semester

1. Physical Exam

Complete a physical exam within the past 12 months and submit the required attestation confirming you can meet the program's technical standards.

2. Tuberculosis (TB) Screening

TB screening within the past 11 months.

Acceptable Options: PPD/TST skin test (2 visits required) OR IGRA blood test (e.g., QuantiFERON or T-SPOT)

Important Notes

- IGRA testing is recommended for students with prior BCG vaccination or difficulty returning for a second appointment.
- Students with a prior positive TB test or BCG vaccination must complete:
 - A TB blood test **OR**
 - A chest x-ray plus TB Symptom ScreenerContact experiential@uhsp.edu for the TB Symptom Screener form.

3. Required Vaccinations

Gather documentation or complete any missing vaccinations PRIOR to the fall semester.

Requirement	Requirement Details
Tdap	Required every 10 years (Td alone is not acceptable)
Hepatitis B	3-dose series or positive titer
MMR	2-dose series or positive titer
Varicella	2-dose series or positive titer; history of disease is not accepted
COVID-19	Complete vaccine series and booster(s) OR vaccine since September 2023

Beginning of Fall Semester

1. Complio Tracking Package

Purchase and set up your Complio tracking package. UHSP undergraduate students may continue using their existing Complio account. All noted requirements will be uploaded and approved in Complio.

2. Background Check

Complete the background check process through Complio. You will need your legal name, Social Security number, and address history for the past 7 years.

3. Drug Screening

Complete the required 10-panel urine drug screen through Complio. Positive results require prescription documentation. Marijuana/THC products are prohibited even if student has a valid prescription.

4. Missouri Pharmacy Intern License

Students will apply for a license after the 10-day census in the fall. All students must maintain an active Missouri Intern Pharmacist License throughout the PharmD program. Technician licenses are not acceptable. Missouri licensure is required even if licensed in another state. Fingerprinting/background check is required through the Missouri Board of Pharmacy.

5. Trainings

Complete online HIPAA and OSHA/Bloodborne Pathogen Trainings.

6. AHA Basic Life Support (BLS)

Students must get American Heart Association “BLS for Healthcare Providers” certification. Red Cross courses are not accepted. Course will be available during Professional Orientation in August.

7. Professional Liability Insurance

Students will apply for professional liability insurance.

8. Individual Medical Insurance

Students must maintain active personal medical insurance and upload proof to Complio.

9. Influenza Vaccine

Students must get an influenza vaccine annually between August 15th and October 1st. Vaccine clinics will be available on campus.

10. APhA Immunization Certificate

Students will sign up for the certificate program in the fall semester and complete in the spring semester.
