

Pharmacist Intern License Requirements

All students enrolled in the Doctor of Pharmacy (Pharm.D.) program at University Health Sciences and Pharmacy are required to have a Missouri Intern Pharmacist license issued by the Missouri Board of Pharmacy and maintain it throughout their enrollment. To maintain an intern license, students must have a valid social security number. More details regarding pharmacist intern licensing is available at: <https://pr.mo.gov/pharmacists.asp>.

To ensure students can meet this requirement, students in the Pharm.D. program must have a valid social security number. Applicants who do not have a social security card are advised to begin the application process. Potential Implications of a Criminal Record for Intern and Pharmacist Licensure

Felony or misdemeanor convictions may prevent a student pharmacist from being licensed as an intern pharmacist or a pharmacist after graduation. Specific licensure requirements vary from state to state. Prospective and current students should contact the Missouri Board of Pharmacy, and any other state they wish to be licensed in, to determine potential implications of a criminal record to decide whether to assume the related risks and costs of the program.

Pharmacist Licensure after Graduation

Pharmacist licensure requirements vary from state to state. To be eligible to be a licensed pharmacist, Pharm.D. graduates must pass the nationwide [North American Pharmacist Licensure Examination \(NAPLEX\)](#). Many states also require passing a state-approved law exam, such as the [Multistate Pharmacy Jurisprudence Examination \(MPJE\)](#) to practice pharmacy in that particular state.

U.S. Department of Education regulation [34 CFR 668.43\(a\)\(5\)\(v\)](#) requires institutions to disclose a list of states and territories where the program “Meets” or “Does not meet” educational requirements for licensure:
